Note from the President

This is a very exciting time of year for me. We are entering the busiest time of the year for the association, so there is a lot of work to do. The payoff is getting to interact with everyone, and meeting the new residents. At the annual meeting, we gained a few board members. Having more people has allowed us to make a change in the distribution of the responsibility amongst members. We now have a chairperson for each of the common areas. This change will allow us to pay better attention to each of the areas and to make improvements in a more organized and efficient way.

The progress we were making with the bioswale project has slowed dramatically. There is a property outside of our neighborhood that serves to catch silt before it reaches our lake. There is an overgrowth of vegetation on the property that makes it nonfunctional. Since the property is not in the association, we are legally limited in the action we can take to restore the property. We are continuing to explore options with this property and with other aspects of the original project.

The annual Pond Party is coming up fast. Please let me know if you can help out. There are many small tasks we need help with that would not require a big commitment. Besides, it's fun to help and work together with your neighbors.

Lake Committee Update:

Growth on the Dam: The November 2016 State of Illinois Inspection Summary:

Residents on the dam are responsible for keeping plant life including shrubs and trees removed. The state does an inspection on the dam every couple of years and tells us where we are deficient. There was a great effort to resolve the findings of the last inspection. Almost all of the residents have resolved these issues. Keeping the dam compliant with state regulations is an ongoing effort because plant growth is constant. Residents that have sinkholes on the lake side of the dam are also responsible for repair. We appreciate the effort these residents continue to make.

Algae:

McCloud is the contracted service company that the board uses to treat the lake with algaecide and dye. The first treatment of the lake was done the week of April 24th. We are already seeing algae on the lake. This is an indication that this year, much like last year, it will be a struggle to keep the lake clear of algae. A major source of the algae problem is related to lawn treatment chemicals that run off from bordering lawns. These chemicals get washed directly into the lake by storm water. We ask that those residents whose property borders the lake, not treat the area approximately 5 yards from the lake shore. We also suggest that those residents that border the lake consider using native plants along the lake shore. This helps to absorb some of the fertilizer and can also help prevent erosion of land into the lake.

Environmental Consulting Firm:

The proposal from Rebecca Olson, owner of Olson Ecological Solutions (OES), was originally presented at the annual meeting in 2016. The feedback on the proposal from the residents has been very favorable. After additional feedback and further studies the board has begun to set aside funds to start the project. It should be noted however that there will be a discussion amongst the board to discern the best approach for this very challenging and evolving project. We are continuing to gather information and form a long term plan to care for our lake.

The current state of the project is in flux because we do not have access to a property that greatly affects the amount of silt that ends up in our lake. We are working to resolve this issue. We cannot proceed with this portion of the project until we can do so legally. We are continuing to look for other ways to reduce algae and prevent the accumulation of silt in the lake.

Wildlife \ Sightings:

We continue to see lots of critters in our neighborhood. Keep us informed if you see any beavers. They can be very destructive. We still have a resident snapping turtle that must weigh over 40 lbs. He was seen snatching ducks from the surface of the lake.

Fishing the lake:

Largemouth bass and blue channel catfish were again stocked in the lake this past fall. Remember the fish caught in the lake are catch and release with the exception of the blue gill which could be planted in your flower beds or gardens as fertilizer. Blue gill fishing remains very good with a catch on every cast from the fishing pier. The dam is private property. Fishing from the dam is not allowed without the property owner's permission. A valid Illinois fishing license is required by the Department of Natural Resources for all residents and guests of Spring Lake Estates. Your activity pass is also required if you are fishing. Last year's pass is sufficient until the new passes are dispersed at the pond party June 3rd. A 5 year stocking plan is currently being worked on. Fish habitat (cribs) is a best practice that will be included in the 5 year plan.

Geese Population:

Please do not feed the geese. They have been an issue for all of us. We don't want to do any more to encourage them to continue coming to our lake.

Spring Lake Clean up:

The annual spring clean-up and cook out was held on April 27th. We had a good turnout by the lake committee and collected over 75 lbs. of debris. Thanks to everyone who has helped throughout the year to keep our lake clean and beautiful.
