PRESIDENT'S MESSAGE

Is it just me or are the years getting shorter? It seems that just yesterday we opened the pond and it was summertime. Now we are coming up on Thanksgiving and Christmas.

The lake project that Joel Helge undertook has been completed in Weymouth Park. He planted wild plants and grasses to stop the erosion in to the lake. In springtime this will be grassland and be home to various forms of wildlife beneficial to the lake and surrounding area. We plan to fence the area off to protect the newly planted grasses and plants.

The current projection is that the dues will increase by 6.2% for 2009. That was the current listed Consumer Price Index for July 2008 upon which we base the increase in dues. If the projection holds, our 2009 association dues will be \$207.00 due on March 1. The invoices will be mailed the first week of January 2009.

We are in good shape financially, but we need to build up reserves for emergencies. While we have some outstanding dues, we are aggressively pursuing them through the Small Claims Court. These cases also include those who were on payment plans and fell behind. While the association knows that these are tough times financially, it is the lack of communication from those in difficulties that cause the association to take legal action. If you are in a difficult situation, please let us know so we can address it.

Our investments are sound. Our C.D. is in a locked rate and when it comes due again, the association will, as it has in the past, exercise due diligence in finding the best rates with a secure financial institution.

This summer also saw a rash of burglaries. Fortunately no one was injured in these incidents. Carol and I were victims of a robbery some time ago and we still remember the pain and the feeling of being violated. Our thoughts and prayers go out to our residents and friends who were victims.

I want to congratulate the residents on becoming more aware of their surroundings and the people who are in the area. Lets keep it up. Make your home and yourself a hard target. The Rockford Police Department will come out and do an evaluation of your home free of charge. Simply call our Community Services Officer (listed on pg. 2) and request one.

While was are on the subject of Police. If you see something that you feel is not right, call 911 immediately. Always teach your children of Stranger Danger and know where they are at all times.

We have noticed some sheds have been built on property within the association without going through the Building Committee. If you build something without contacting Tom McNeany, you run the risk of legal action as this is a violation of the by-laws. The proper procedure is to contact your immediate neighbors to see if they have any concerns, get a sketch or plans of your shed or fence, then submit them to Tom McNeany, Building Committee Chair.



As president of this association, I have received a number of complaints regarding various issues. All of them have merit, except one. The issue of dues. I have heard it all from "we should make those not in the association pay dues" to "why should we pay dues when we don't use the parks". Another popular one is "why should we pay for the lake if we don't have full access to it", or my favorite, "the dues are too high"!

The fact of the matter is that when you purchased your home in Spring Lake Estates, you knew that you were buying into an area that was controlled by a homeowner's association. In fact many of our current residents served on those first boards. There is no way for an individual homeowner to "opt out" of this or any homeowner's association.

We all pay dues for the common good of our area. Ask any realtor. Spring Lake Estates is a highly desirable area for those who like a nice house at a reasonable price, great parks, and a fantastic neighborhood.

We all benefit from the parks and lake (with its new handicap accessible fishing dock), whether we use them or not. It is reflected in the value of our homes.

As far as our dues being too high, a check of the local area show the average association dues is between \$850 to well over \$1,000 per year and they don't have what we offer. We are well below the average and do a lot with very little.

So while I know that people will still complain about the dues, I hope this puts things into perspective.

NEW LUMINARY FUN!

Sunday, December 14th, 4:30 p.m., together we light our luminary, dim our entry lights, and warm our neighborhood hearts again. Last year's display

was awesome. More than half the homes in the association participated turning our neighborhood into a winter wonderland! Lets see if we can surpass it this year! Plan your display now and collect your supplies early! For a traditional display, here's what you'll need:

- White, weather resistant luminary bags; use approximately 1 per every 6 - 9 feet of your path (or whatever looks good to you).
- 2. White luminary candles; use 1 per bag.
- 3. Sand or kitty litter; approximately 2 cups per bag.
- 4. Long lighter; like the one to start grills.

These supplies can be found at Zanocco Ace Hardware at 1605 N. Alpine in the Edgebrook Shopping Center or ACE Hardware at 5874 East Riverside in the shopping center at Riverside and Mulford. (Also available elsewhere.)

To assemble the luminaries:

- 1. fold bag tops down about 2" to anchor the bag shape
- 2. put 2 cups of sand or kitty litter in each bag
- after placing your luminary bags along your drive or pathway, securely mount a candle in the center of the sand within the bags. (Take care that the area is free of any debris or obstruction.)

Instead of candles, battery operated lights of various sizes are available. (Walmart carries small oil lamps made specifically to be placed inside candle holders or luminaries.) Metal luminary "bags" are also available. Or go creative with milk cartons, jars or ice!

The luminaries will be lit at 4:30 p.m. on Sunday, December 14th for that evening only. Grab your camera, walk the neighborhood, greet your neighbors, or plan a party for that day. Enjoy the beauty of the season!

Collect your luminary remains the next day. Reuse, recycle or share what you can.
